## CONDITIONS OF ENTRY

The condition of entry applies to all person entering Jummps Trampoline Park for use of the facilities.

By participating in recreational or other activities, you accept the inherent risks associated with those activities at our premises.

As such you agree to:

- a) Release Jummps Parkwood PTY LTD and all persons or corporations associated with directly or indirectly with the conduct of all recreational activities from all claims, demands and proceedings arising out of your participation and;
- b) Indemnifies and holds harmless Jummps Parkwood Pty Ltd and all associated people, entities or companies against all liability (including liability for their negligence and the negligence of others). Damage and expense associated with all injuries, loss or damage arising out of or connected with your participation in the recreational activities, and the participation of ant person you have booked the recreational services for.

BASICALLY, YOU ARE AGREEING NOT TO TAKE ANY LEGAL ACTION (SUE) JUMMPS PARKWOOD PTY LTD IF YOU HURT YOURSELF OR SOMEONE ELSE AND YOU UNDERSTAND THAT YOU ARE LIABLE IF YOU DO GET HURT (YOU JUMP AT YOUR OWN RISK)

You must be over 18 to sign this legal document, If you are under 18 the contract must be signed by a parent or guardian in which the parent or guardian agrees to be bound by these conditions on their behalf. YOU MUST HAVE READ THE RULES AND RESPONSIBILITIES OF JUMMPS Parkwood Pty Ltd, you must comply with these rules and responsibilities and any directions issued from Jummps trampoline Park staff.

**WARNING:** The recreational training, fitness and coaching activities provided by Jummps Trampoline Park carry inherent risks, which can and may result in personal injury and / or death. These risks include sprains, twists, broken bones, spinal injury, paralysis, physical injury and/or death which is why it is important to understand the conditions of entry and comply with all instructions provided by or on behalf of Jummps Trampoline Park. The participant hereby agrees to be bound by the terms and conditions of this contract with Jummps Parkwood PTY LTD trading as Jummps Trampoline Park.

## YOU MUST NOT:

Before or during the recreational activities consume alcohol, chew gum, smoke on the premises or engage in any rough play / fighting. Jumpers must not attempt skills beyond their own abilities increasing the risk of serious injury.

For safety and Hygiene reasons:

- a) The maximum weight limit for an individual is 115kg.
- b) You must wear approved grip socks for the duration of the recreational activity.
- c) Mobile phones and other electronic devices must not be used during the recreational activity.

You consent and consent on behalf of any child as the parent or guardian of the child to receiving and medical treatment that Jummps Trampoline Park deems necessary during or after the engagement of the recreational activities and for any associated costs. You are responsible for all your own personal properties on the premises at all times.

BY PARTICIPATING IN ACTIVITES IN THE VENUE YOU ACKNOWLEDGE THAT YOU HAVE READ AND UNDERSTOOD THE CONDITIONS OF ENTRY SET OUT ABOVE AND AGREE TO THEM. YOU ACKNOWLEDGE AND ACCEPT THAT SERIOUS ACCIDENTS CAN AND DO OFTEN OCCUR WHICH MAY RESULT IN SERIOUS INJURY AND YOU ACCEPT YOU ARE JUMPING AT YOUR OWN RISK.
